AN ORDINANCE TO AMEND ORDINANCE NO. 13, AN ORDINANCE TO REGULATE THE PARKING OF MOTOR VEHICLES WITHIN THE VILLAGE OF DANSVILLE

The Village of Dansville Ordains:

SECTION 1. Section 2 of Ordinance No. 13 enacted July 12, 1982, an Ordinance to Regulate the Parking of Motor Vehicles within the Village of Dansville, is hereby amended to read as follows:

Section 2. It shall be unlawful for any person, firm, partnership, association or corporation to park or leave stopped any motor vehicle in excess of two continuous hours between the hours of 6:00a.m. and 6:00p.m. on the following streets: Jackson Street between Cook Street and Chestnut Street; the north side of Cook Street; Adams Street from Dakin Street to Grove Street; and the north side of South Street from Grove Street to the Dansville High School.

SECTION 2. Section 3 of Ordinance No. 13 enacted July 12, 1982, an Ordinance to Regulate the Parking of Motor Vehicles within the Village of Dansville, shall be amended to read as follows:

Section 3. It shall be unlawful for any person, firm, partnership, association or corporation to park or leave stopped any motor vehicle at any time on the following streets: The west side of Jackson Street from Adams Street to Cook Street; the south side of Cook Street; the south side of South Street; the north and south sides of Johnson Street.

SECTION 3. Section 8 of Ordinance No. 13 enacted July 12, 1982, an Ordinance to Regulate the Parking of Motor Vehicles within the Village of Dansville, shall be amended to read as follows:

Section 8. The following fines are hereby designated for parking violations:
