

ORDINANCE NO. 3

(Enacted June 17, 1981)

AN ORDINANCE TO ADOPT BY REFERENCE
THE UNIFORM TRAFFIC CODE FOR MICHIGAN CITIES,
TOWNSHIPS AND VILLAGES TOGETHER WITH
1979 AMENDMENTS THERETO

The Village of Dansville ordains:

SECTION 1. Code adopted.

The Uniform Traffic Code for cities, townships and villages promulgated by the Commissioner of State Police on February 14, 1958 and published in Supplement No. 13, and as amended both on February 14, 1961 and published in Supplement No. 25, and on February 26, 1968 and published in Supplement No. 54, and on August 4, 1976 and published in Supplement No. 88, to the 1954 Michigan Administrative Code, in accordance with Public Act 62 of 1956, State of Michigan, is hereby adopted by reference as if in this Ordinance as modified.

SECTION 2. Amendments adopted.

Amendments to the Uniform Traffic Code promulgated as emergency rules by the Department of State Police effective July 17, 1979, as a result of amendments to Act 62, P.A. 1956, contained in Act No. 514, P.A. 1978, which requires the Director of State Police to specify whether a person who violates a particular provision of the Uniform Traffic Code is guilty of a misdemeanor or is responsible for a civil infraction, and published as emergency rules on June 26, 1979 as a supplement to the 1976 publication of the full Uniform Traffic Code, in accordance with Act No. 65 of the Michigan Public Acts of 1956, are hereby adopted by reference amending and adding similarly numbered sections to the Code.

SECTION 3. References in Code.

References in the Uniform Traffic Code for Michigan Cities, Townships and Villages to "governmental unit" shall mean the Village of Dansville.

SECTION 4. Notice to be published.

The Village Clerk shall publish this Ordinance in the manner required by law and shall at the same time publish a supplementary notice setting forth the purpose of the said Uniform Traffic Code and of the fact that complete copies of the Code are available at the office of the Clerk for inspection by the public at all times.

SECTION 5. Conflicting ordinances repealed.

All other ordinances inconsistent with the provisions of the Uniform Traffic Code are, to the extent of such inconsistency, hereby repealed.

SECTION 6. Effective date.

This Ordinance shall take effect twenty (20) days after its approval by the Village Council.
