## ORDINANCE NO. 11

(Enacted March 8, 1982)

AN ORDINANCE TO REGULATE THE COLLECTION AND DISPOSAL OF GARBAGE, RUBBISH AND OTHER WASTE MATERIALS

The Village of Dansville ordains:

## SECTION 1. Definitions.

- (a) The term "garbage" as used herein shall include all refuse and waste attendant to the preparation, dressing or cooking of food and unwashed tin, paper and other types of combustible refuse food containers.
- (b) The term "rubbish" as used herein shall include ashes, dirt, tin cans, washed food containers, waste paper, leaves, grass and similar organic material, glass and other similar waste materials.
- (c) The term "refuse building materials" as used herein shall include all wood, plaster, stone, brick or other waste and unused building materials resulting from the repair or construction of any building or structure.
- (d) The term "brush" as used herein shall include all tree and shrubbery trimmings.
- (e) The term "suitable receptacle" as used herein shall include any water-tight metal or plastic container or plastic bag capable of being sufficiently sealed to keep out water and to prevent disturbance by animals and capable of being easily handled and loaded by one person.
- SECTION 2. It shall be the duty of all owners, proprietors, lessees, occupants or other persons in charge of any dwelling house, store, manufacturing establishment, office building or other structure in the Village of Dansville, to place or cause to be placed all garbage and rubbish accumulating on the premises in suitable receptacles.
- SECTION 3. It shall be the duty of any such person referred to in Section 2 to cut and bind all accumulations of brush into lengths not exceeding three feet and bundles capable of being easily handled and loaded by one person.
- SECTION 4. Any person referred to in Section 2 desiring any garbage, rubbish or brush to be disposed of by the Village of Dansville shall be required to place or cause to be placed the same on the days scheduled for collection thereof in suitable receptacle in the parkway between the sidewalk and curb lines in front of the premises provided however that no such receptacle shall be so placed for collection prior to twelve o'clock noon preceeding the day of collection.

SECTION 5. It shall be the duty of the owner, contractor or other person responsible for construction work on any premises in the Village of Dansville to remove therefrom all surplus construction and refuse building material within thirty (30) days after the completion of such construction work and dispose of the same in accordance with the provisions of this Ordinance.

SECTION 6. The Superintendent of Public Works is hereby authorized to cause to be collected any garbage, rubbish or brush allowed to accumulate on any property in the Village of Dansville by any person referred to in Section 2 in violation of this Ordinance and add the cost thereof assessable to the taxes due by the owner of said property.

SECTION 7. It shall hereafter be unlawful for any person to burn any garbage, rubbish, brush or other waste materials other than leaves within the Village of Dansville except in a fully enclosed incinerator installed within a permanent building.

SECTION 8. It shall be lawful to burn leaves on the premises by any person referred to in Section 2 provided such burning is conducted without creating a fire hazard and by or under the supervision of such person or other responsible person over the age of 15 years, between the hours of 7:00 a.m. and 9:00 p.m.

SECTION 9. Any person, firm or corporation violating any provision of this Ordinance shall upon conviction thereof be punished by a fine not to exceed Five Hundred (\$500.00) Dollars or by imprisonment not to exceed ninety (90) days, or both.

SECTION 10. This Ordinance shall take effect twenty (20) days from the date of publication hereof.
