

ORDINANCE NO. 13

(Enacted July 12, 1982)

AN ORDINANCE TO REGULATE THE PARKING
OF MOTOR VEHICLES WITHIN THE VILLAGE OF DANSVILLE

The Village of Dansville ordains:

SECTION 1. It shall be unlawful for any person, firm, partnership, association or corporation to park or leave stopped, any motor vehicle on any Village street between the hours of 2:00 A.M. and 6:00 A.M. from November 1 to March 1.

SECTION 2. It shall be unlawful for any person, firm, partnership, association or corporation to park or leave stopped any motor vehicle in excess of two continuous hours between the hours of 6:00 A.M. and 6:00 P.M. on the following streets: Jackson Street between Cook Street and Chestnut Street; the north side of Cook Street; and Adams from Dakin to Grove.

SECTION 3. It shall be unlawful for any person, firm, partnership, association or corporation to park or leave stopped any motor vehicle at any time on the following streets: the west side of Jackson Street from Adams Street to Cook Street; the south side of Cook Street.

SECTION 4. Any public parking place within the Village designated for use by handicapped persons by appropriate signs is at all times reserved exclusively for use by such persons or for use by any persons assisting any handicapped persons.

SECTION 5. For the purposes of facilitating the enforcement of this Ordinance, pursuant to Section 8395 of Act 154, P.A. 1968, the Dansville Parking Violations Bureau is hereby created.

SECTION 6. The Bureau may accept pleas of guilty to parking violations and assess and collect the fines specified herein.

SECTION 7. The Village Clerk shall be the Director of said Bureau and together with the Deputy Village Clerk shall be authorized to collect all fines assessed herein which shall be payable during normal working hours at the Village Office.

SECTION 8. The following fines are hereby designated for parking violations:

- a. Two-hour zone - \$2.00
- b. Parking in no parking zone - \$5.00
- c. Unauthorized parking in a restricted parking area - \$10.00
- d. Double parking - \$5.00
- e. Improper parking - \$5.00

SECTION 9. Any person, firm, partnership, association or corporation to whom a parking violation has been issued desiring to enter a plea of not guilty to such violation may do so before the nearest available magistrate and shall be entitled to trial under the rules and procedure of the District Court for the trial of a violation of a Village ordinance.

SECTION 10. The Village President, or his designee, is authorized to seek a warrant for the arrest of any person failing to pay any fine provided herein or enter a plea of not guilty within ten (10) days of the occurrence of any violation provided herein.

SECTION 11. This Ordinance shall take effect immediately upon publication hereof.
