

ORDINANCE NO. 23

(Enacted May 14, 1984)

AN ORDINANCE TO AMEND ORDINANCE NO. 2 (Enacted June 17, 1981)  
FIXING THE COMPENSATION FOR THE PRESIDENT, TRUSTEES  
AND OTHER OFFICERS OF THE VILLAGE OF DANSVILLE

The Village of Dansville ordains:

SECTION 1. Ordinance No 2 enacted June 17, 1981 is hereby amended in its entirety effective April 1, 1984 to provide as follows:

SECTION 1. The president of the Village shall receive the sum of One hundred twentyfive (\$125.00) Dollars for each regular and special meeting of the Village Council by him or her attended during his or her term of office.

SECTION 2. The Trustees of the Village shall each receive the sum of Thirty (\$30.00) Dollars for each regular or special meeting of the Village Council by them respectively attended during their term of Office.

SECTION 3. The Clerk of the Village shall receive the sum of One Thousand (\$1,000.00) Dollars per year during his or her term of office.

SECTION 4. The Treasurer of the Village shall receive the sum of Seven Hundred (\$700.00) Dollars per year during his or her term of office.

SECTION 5. In addition to the above, each of the above specified officers of the Village shall be reimbursed for any and all expenses incurred by them in performing the functions of their respective offices under such terms and conditions as the council shall provide by resolution.

SECTION 6. Reimbursable expenses shall include but not be limited to funds incurred by any office for transportation expenses, telephone expenses, postage, and supplies, incurred directly in connection with performing any function assigned to them by the Village Council or by reason of their officer.

SECTION 7. All payments for such compensation and expenses shall be made out of the general fund of the Village treasury at such times as the Council may authorize by appropriate resolution.

SECTION 8. The President and Trustees shall receive no other compensation for services performed for and on behalf of the Village during the term of their office, and in no case shall any Officer specified herein receive compensation for any meetings not actually attended.

SECTION 9. The Clerk and Treasurer may receive such additional compensation as the Village may from time to time prescribe by appropriate resolution.

SECTION 2. This Ordinance shall take effect immediately upon publication.
